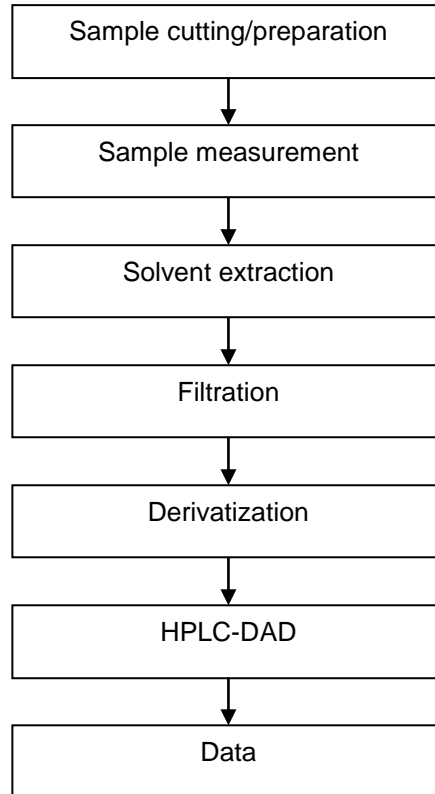

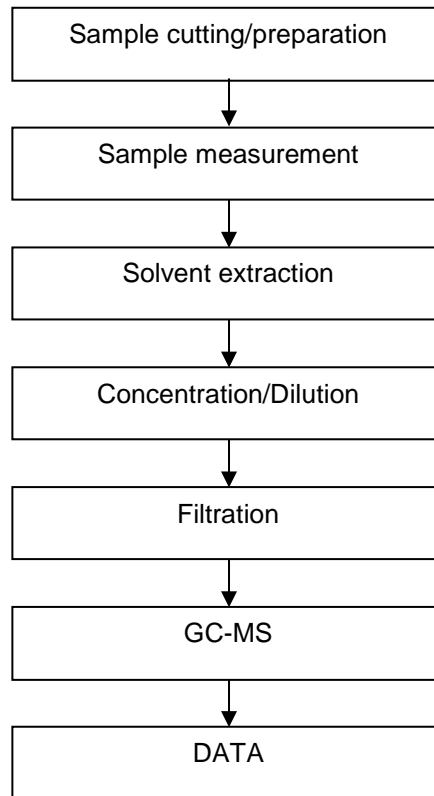
Formaldehyde Testing Flow Chart

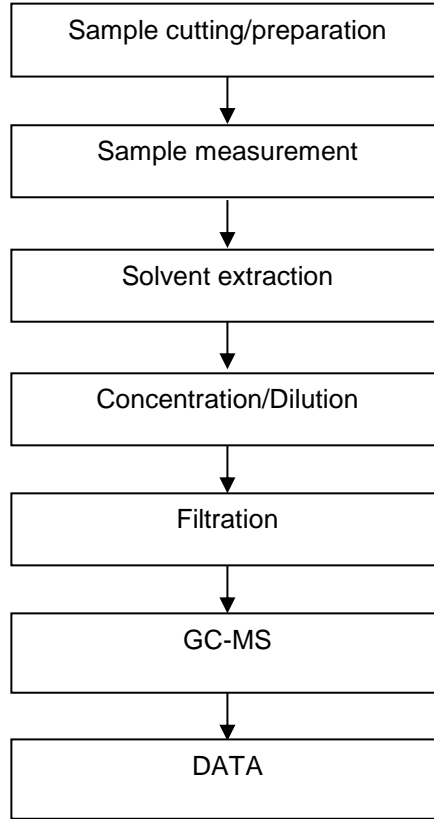
DMF (N, N-dimethylformamide) Testing Flow Chart

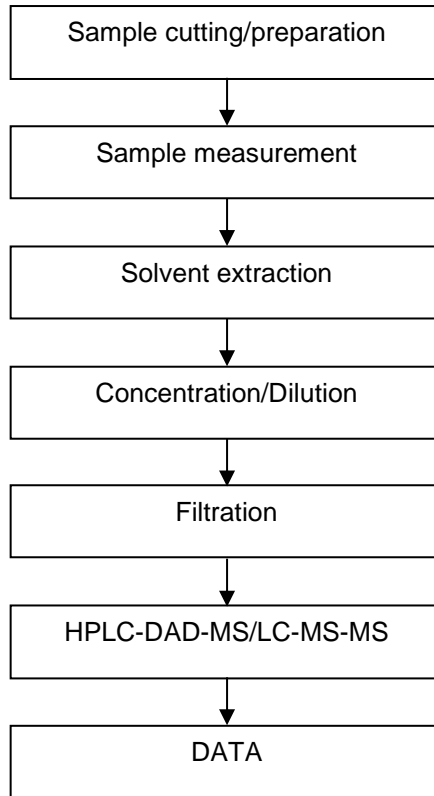
Phthalates Testing Flow Chart
